7. Bids must be duly received by the BAC Secretariat, Capitol Complex, Camimil, Calapan City, Oriental Mindoro on or before **December 10, 2021 at 8:30 a.m.** All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Claus 18.

Bid opening shall be on **December 10, 2021 at 9:00 a.m. at BAC Conference Room, Provincial Capitol Complex, Camimil, Calapan City, Oriental Mindoro.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.
