CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 28 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and DXB CONSTRUCTION with office address at Bayabas St., Lalud, Calapan City, Oriental Mindoro represented by ENGR. EMILIA S. FAMPULME, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Rehabilitation/ Improvement of Barangay Hall at Pinagsabangan II, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION FOUR HUNDRED EIGHTY SEVEN THOUSAND FIVE HUNDRED PESOS ONLY (Php 2,487,500.00) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
