CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 20 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SOSEP BUILDERS with office address at Campaasan, Bulalacao, Oriental Mindoro represented by ENGR. ERNESTO C. VILLAS, JR., Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Installation of Water System to the Newly Constructed Building at Leuteboro NHS, Socorro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount EIGHT HUNDRED TWENTY ONE THOUSAND ONE HUNDRED EIGHTY TWO PESOS AND 66/100 ONLY (Php 821,182.66) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
