**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **20% Development Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Bridge going to School at Dulangan II, Baco, Oriental Mindoro (Construction of Box Culvert: Source of Aggregates; Mayabig River, Baco; Box Culvert Dimension (2 Barrel) Total Span=6.00m, Height=3.00m, Width=6.00m, Thickness=0.30m, Approach: (Gravel Road) Length=74.00m, Width=7.00m);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-567) in PhilGEPS Website on **December 08, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Bridge going to School at Dulangan II, Baco, Oriental Mindoro (Construction of Box Culvert: Source of Aggregates; Mayabig River, Baco; Box Culvert Dimension (2 Barrel) Total Span=6.00m, Height=3.00m, Width=6.00m, Thickness=0.30m, Approach: (Gravel Road) Length=74.00m, Width=7.00m);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. SOSEP BUILDERS

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **December 29, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **December 29, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **SOSEP BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
