CONTRACT AGREEMENT

THIS AGREEMENT, made this JAN 21 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and GREEN ISLAND ENTERPRISES with office address at Maligaya, Gloria, Oriental Mindoro represented by JOANNE D. ENRIQUEZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair /Renovation of SK Hall at Brgy. Aplaya, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY SIX THOUSAND TWO HUNDRED SEVENTY SEVEN PESOS AND 92/100 (Php 986,277.92) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
