(INFRASTRUCTURE)**

**WHEREAS**, there is an infrastructure project funded through the LGSF-DRRP Fund 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair of 2 CL in Doña Asuncion Reyes MES, Pinamalayan, Oriental Mindoro (Removal and Replacement of Ceilings for 2 Classrooms (includes outside Ceiling) Removal of Steel Matting Walls and Replacement of Masonry and Plastering with Installation of New Doors and Windows.- Painting Works includes the replaced Ceiling and Walls Only, 4 pcs 1.4m x 1.4m Window Grills for Front of 2 Classroom.);**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-570) in PhilGEPS Website on **December 20, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair of 2 CL in Doña Asuncion Reyes MES, Pinamalayan, Oriental Mindoro (Removal and Replacement of Ceilings for 2 Classrooms (includes outside Ceiling) Removal of Steel Matting Walls and Replacement of Masonry and Plastering with Installation of New Doors and Windows.- Painting Works includes the replaced Ceiling and Walls Only, 4 pcs 1.4m x 1.4m Window Grills for Front of 2 Classroom.);**

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. SOSEP BUILDERS**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **December 29, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **December 29, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **SOSEP BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
