BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

WHEREAS, there is an infrastructure project funded through the LGSF-DRRP Fund 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Completion of Covered Court at Domingo Yu Chu MNHS, Maluanluan, Pola, Oriental Mindoro (Completion of Covered Court at Domingo Yu Chu Maluanluan w/ construction of (2 span-12m x 15.6m). Provision of concrete pavement (6m x 15.6m));

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-572) in PhilGEPS Website on December 20, 2021 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Completion of Covered Court at Domingo Yu Chu MNHS, Maluanluan, Pola, Oriental Mindoro (Completion of Covered Court at Domingo Yu Chu Maluanluan w/ construction of (2 span-12m x 15.6m). Provision of concrete pavement (6m x 15.6m));

WHEREAS, in response to the said advertisement, one (1) prospective bidder/contractor submitted application for eligibility and purchased bid documents;

1. LAS MINAS DE ORO CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on December 29, 2021, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on December 29, 2021 eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **LAS MINAS DE ORO CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
