DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and LAS MINAS DE ORO CONSTRUCTION with office address in Sta. Maria Village, Calapan City, Oriental Mindoro represented by EVELYN A. ABAS, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Covered Court at Domingo Yu Chu MNHS, Maluanluan, Pola, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY THOUSAND FIVE PESOS AND 91/100 ONLY (Php 980,005.91) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
