# Construction of Free-Range Poultry Breeder House with Hatchery in Brgy. Maligaya, Gloria, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the LGSF-DRRP Fund 2021 intends to apply the sum of Six Hundred Ninety Nine Thousand Three Hundred Two Pesos and 56/100 Only (Php 699,302.56) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Free-Range Poultry Breeder House with Hatchery in Brgy. Maligaya, Gloria, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Free-Range Poultry Breeder House with Hatchery in Brgy, Maligaya, Gloria, Or. Mindoro". Completion of the Works is 29 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
