BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

WHEREAS, there is an infrastructure project funded through the LGSF-DRRP Fund 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Repair of 4 CL in Petra Garis MES, Naujan, Oriental Mindoro (Repair of 4 Classroom (3 Classroom 8m x 6m and 1 Classroom 6.8m x 7.9m) Ceiling of Grade 5 & Grade 1 Roof sheet, Painting (concrete, ceiling and roof) and electrical works);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-575) in PhilGEPS Website on December 20, 2021 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Repair of 4 CL in Petra Garis MES, Naujan, Oriental Mindoro (Repair of 4 Classroom (3 Classroom 8m x 6m and 1 Classroom 6.8m x 7.9m) Ceiling of Grade 5 & Grade 1 Roof sheet, Painting (concrete, ceiling and roof) and electrical works);

WHEREAS, in response to the said advertisement, one (1) prospective bidder/contractor submitted application for eligibility and purchased bid documents;

1. DK CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on December 29, 2021, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on December 29, 2021 eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **DK CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
