**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

Resolution No. 595, Series of 2021

WHEREAS, there is an infrastructure project funded through the **General Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Rehab of Barangay Hall at Zone II, Pinamalayan, Oriental Mindoro (Rehabilitation of barangay hall with repair of concrete gutter, replacement of damaged ceiling with paintings, concrete topping (office of Brgy. Captain, Secretary and Senior Citizen's) with replacement of tile works, electrical works, doors and painting works {front elevation (1st and 2nd floor) and inside (first floor only)});**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-576) in PhilGEPS Website on **December 20, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Rehab of Barangay Hall at Zone II, Pinamalayan, Oriental Mindoro (Rehabilitation of barangay hall with repair of concrete gutter, replacement of damaged ceiling with paintings, concrete topping (office of Brgy. Captain, Secretary and Senior Citizen's) with replacement of tile works, electrical works, doors and painting works {front elevation (1st and 2nd floor) and inside (first floor only)});**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. SOSEP BUILDERS

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **December 29, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **December 29, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **SOSEP BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **December 29, 2021** found out that bid price of **SOSEP BUILDERS** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
