# Rehab of Barangay Hall at Zone II, Pinamalayan, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the General Fund 2021 intends to apply the sum of Five Hundred Ninety Five Thousand Nine Hundred Eighty Six Pesos and 48/100 Only (Php 595,986.48) being the approved Budget for the Contract (ABC) to payment under the contract for "Rehab of Barangay Hall at Zone II, Pinamalayan, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Rehab of Barangay Hall at Zone II, Pinamalayan, Or. Mindoro". Completion of the Works is 34 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC.
