CONTRACT AGREEMENT

NOV 0 2 2021 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and F.S SUGAY CONSTRUCTION & SUPPLIES with office address in Mahogany St. Sto. Niño, Calapan City, Oriental Mindoro represented by FRANCILITA S. SUGAY, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Oriental Mindoro VCO Processing and Marketing Center in Brgy. Calima, Pola, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FIVE MILLION SEVEN HUNDRED SIXTY FIVE THOUSAND SIX HUNDRED NINETY PESOS AND 20/100 ONLY (Php 5,765,690.20) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as 1. are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - Request for Quotation (RFQ) including the detailed computation of costs A. per item of work as per Bill of Quantities.
 - B. Terms and Conditions;
 - C. Bill of Quatities (BOQ);
 - D. Plans & Specifications;
 - E. Addenda and/ or Supplemental, if any;
 - F. Eligibility, Technical and Financial Documents;
 - G. Letter of Acceptance/ Notice of Award;
 - H. Performance Security; and
 - Construction Safety and Health Program approved by the Department 1. of Labor and Employment (DOLE).
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- The Entity hereby covenants to pay the Contractor in consideration of the 4. execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
