**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

Resolution No. 009, Series of 2022

WHEREAS, there is an infrastructure project funded through the LGSF-FALGU FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Multi-Purpose Building in Bongabong, Oriental Mindoro (Construction of 8.0m x 14.0m Drying Facility. Embankment (H=1.00m);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-006) in PhilGEPS Website on **January 03, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Multi-Purpose Building in Bongabong, Oriental Mindoro (Construction of 8.0m x 14.0m Drying Facility. Embankment (H=1.00m);**

WHEREAS, in response to the said advertisement, **two (2) prospective bidders/contractors** submitted application for eligibility and purchased bid documents;

- 1. WEBUILD CONSTRUCTION**
- 2. ANSAVILLA CONSTRUCTION AND DEVELOPMENT CORPORATION**

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **January 24, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **January 24, 2022** eligibility check were conducted to two (2) bidders/contractors mentioned above and the bid of **ANSAVILLA CONSTRUCTION AND DEVELOPMENT CORPORATION** was automatically disqualified due to the summary of bidder's assets and liabilities declared on NFCC was not based on the 2020 Audited Financial Statement;

WHEREAS, the bid proposal submitted by **WEBUILD CONSTRUCTION** was examined and found to be substantially complied with the technical and financial proposals, thereby making the bid proposal passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the bid evaluation conducted on **January 24, 2022** found no minor mathematical correction to be made in the financial component, thus bid price remains the same.
