RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **LGSF-DRRP FY 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair of 2 CL in Mariano P. Garcia MS, Naujan, Oriental Mindoro (Repair of classroom w/ Removal and replacement of ceiling, roofing and roof framing. Electrical works (Initial Installation))**;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-009) in PhilGEPS Website on **January 08, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair of 2 CL in Mariano P. Garcia MS, Naujan, Oriental Mindoro (Repair of classroom w/ Removal and replacement of ceiling, roofing and roof framing. Electrical works (Initial Installation))**;

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. WINKONSTRUCT ENTERPRISES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **January 17, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **January 17, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **WINKONSTRUCT ENTERPRISES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
