DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WINKONSTRACT ENTERPRISES with office address at Unit 17, Filipiniana Complex, Calapan City, Oriental Mindoro represented by ENGR. LOUIGI ALMOND P. GAYUTIN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair of 2 CL in Mariano P. Garcia MS, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount THREE HUNDRED NINETY EIGHT THOUSAND SEVEN HUNDRED SIXTY SIX PESOS AND 54/100 ONLY (Php 398,766.54) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
