Repair of 4 CL in Bulalacao CS, Bulalacao, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the LGSF DRRP FY 2021 intends to apply the sum of Seven Hundred Ninety Nine Thousand Five Hundred Twenty Seven Pesos and 58/100 Only (Php 799,527.58) being the approved Budget for the Contract (ABC) to payment under the contract for "Repair of 4 CL in Bulalacao CS, Bulalacao, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Repair of 4 CL in Bulalacao CS, Bulalacao, Or. Mindoro". Completion of the Works is 35 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
