CONTRACT AGREEMENT

THIS AGREEMENT, made this _______ between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SOSEP BUILDERS with office address at Campaasan, Bulalacao, Oriental Mindoro represented by ENGR. ERNESTO C. VILLAS, JR., Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair of 2 CL in Natividad De Joya MS, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount THREE HUNDRED NINETY EIGHT THOUSAND ONE HUNDRED SEVEN PESOS AND 79/100 ONLY (Php 398,107.79) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
