## CONTRACT AGREEMENT


THIS AGREEMENT, made this FEB 2 1 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RJJJ ENGINEERING SERVICES with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. RECTO, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Multi-Purpose Hall at Fortunato Perez High School at Concepcion, Victoria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount EIGHT HUNDRED TWENTY FOUR THOUSAND EIGHT HUNDRED EIGHTEEN PESOS AND 92/100 (Php 824,818.92) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## **NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - D. Performance Security
  - E. Credit Line or Net Financial Contracting Capacity.
  - F. PERT/CPM Diagram and bar chart with S-curve.
  - G. Other documentary requirements
    - 1. Equipment Utilization Schedule
    - 2. Manpower Utilization Schedule
    - 3. Construction Method
    - 4. Construction Schedule and S-Curve
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
