# BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

### Resolution No. 018, Series of 2022

WHEREAS, there is an infrastructure project funded through the LGSF-DRRP FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Construction/Opening of Road Section at San Roque, Bulalacao, Oriental Mindoro (Concreting of Road:PCCP: L of PCCP=127.00m, W of PCCP=4.00m, T of PCCP=0.23m, Thk 201=0.20, SHOULDER: Shoulder BS 0.50m);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-013-A) in PhilGEPS Website on January 22, 2022 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Construction/Opening of Road Section at San Roque, Bulalacao, Oriental Mindoro (Concreting of Road:PCCP: L of PCCP=127.00m, W of PCCP=4.00m, T of PCCP=0.23m, Thk 201=0.20, SHOULDER: Shoulder BS 0.50m);

WHEREAS, in response to the said advertisement, one (1) prospective bidder/contractor submitted application for eligibility and purchased bid documents;

#### 1. NAMNAMA CONSTRUCTION SUPPLIES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on January 31, 2022, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on January 31, 2022 eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by NAMNAMA CONSTRUCTION SUPPLIES was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
