**WHEREAS**, there is an infrastructure project funded through the LGSF-DRRP FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Road at Lopez, Ilaya, Calapan City, Oriental Mindoro (Concreting of Road: Source of Aggregates: Tigkan River; Station Limit 0+000.00-0+043.00, L of PCCP=43.00m, W of PCCP=4.00m, T of PCCP=0.23m, Thk. of 201=0.20m, W of Shoulder=0.80m (both side), Total Length=43.00m);**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-014-A) in PhilGEPS Website on **January 22, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Concreting of Road at Lopez, Ilaya, Calapan City, Oriental Mindoro (Concreting of Road: Source of Aggregates: Tigkan River; Station Limit 0+000.00-0+043.00, L of PCCP=43.00m, W of PCCP=4.00m, T of PCCP=0.23m, Thk. of 201=0.20m, W of Shoulder=0.80m (both side), Total Length=43.00m);**

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. LAS MINAS DE ORO CONSTRUCTION**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **January 31, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **January 31, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **LAS MINAS DE ORO CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
