CONTRACT AGREEMENT

THIS AGREEMENT, made this FEB 1 8 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and LAS MINAS DE ORO CONSTRUCTION with office address in Sta. Maria Village, Calapan City, Oriental Mindoro represented by EVELYN A. ABAS, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Lopez, Ilaya, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount THREE HUNDRED SEVENTY ONE THOUSAND THREE PESOS AND 70/100 ONLY (Php 371,003.70) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - D. Performance Security
 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements
 - 1. Equipment Utilization Schedule
 - 2. Manpower Utilization Schedule
 - 3. Construction Method
 - 4. Construction Schedule and S-Curve
