BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 020, Series of 2022

WHEREAS, there is an infrastructure project funded through the LGSF-DRRP FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Repair of 2 CL in Alimawan ES, Bulalacao, Oriental Mindoro (Roof of 2 CL, Trusses of 2 CL, Ceiling of 1 CL (inside) Electrical of 2 CL);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-015-A) in PhilGEPS Website on January 22, 2022 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Repair of 2 CL in Alimawan ES, Bulalacao, Oriental Mindoro (Roof of 2 CL, Trusses of 2 CL, Ceiling of 1 CL (inside) Electrical of 2 CL);

WHEREAS, in response to the said advertisement, one (1) prospective bidder/contractor submitted application for eligibility and purchased bid documents;

1. 811 TRADING AND CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on January 31, 2022, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on January 31, 2022 eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by 811 TRADING AND CONSTRUCTION was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on January 31, 2022 found out that bid price of 811 TRADING AND CONSTRUCTION is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the Single Calculated Bid;
