FEB 2 1 2022 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 811 TRADING AND CONSTRUCTION with office address at 9 Palayan St., Paclasan, Roxas, Oriental Mindoro represented by ENGR. ARMIN C. SUZARA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair of 2 CL in Alimawan ES, Bulalacao, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount THREE HUNDRED NINETY EIGHT THOUSAND EIGHT HUNDRED FORTY SIX PESOS AND 45/100 ONLY (Php 398,846.45) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
