RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the LGSF-DRRP FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair of 2 CL in Simon Gayutin MES, Victoria, Oriental Mindoro and Repair of 2 CL in San Carlos ES, Naujan, Oriental Mindoro (Remove & replace of roof. Construction of 2 units column and beams. Construction of wall at left side only and wall footing and dowel bars for the other proposed wall./ Source of Aggregates: Alcate, G1 CL-Repair of Ceiling (in & out) & Wall Paint (in only) Window 2, 2nd CL-Replacement of Doors and Windows, Cement Flooring, Repair of Ceiling w/ Paint (in & out), Paintings of Wall (in & out) Electrical, Plaster of Gable);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-016-B) in PhilGEPS Website on **February 12, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair of 2 CL in Simon Gayutin MES, Victoria, Oriental Mindoro and Repair of 2 CL in San Carlos ES, Naujan, Oriental Mindoro (Remove & replace of roof. Construction of 2 units column and beams. Construction of wall at left side only and wall footing and dowel bars for the other proposed wall./ Source of Aggregates: Alcate, G1 CL-Repair of Ceiling (in & out) & Wall Paint (in only) Window 2, 2nd CL-Replacement of Doors and Windows, Cement Flooring, Repair of Ceiling w/ Paint (in & out), Paintings of Wall (in & out) Electrical, Plaster of Gable);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. LAS MINAS DE ORO CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **February 21, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **February 21, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **LAS MINAS DE ORO CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
