Bid opening shall be on **February 21, 2022 at 9:00 a.m. at BAC Conference Room, Provincial Capitol Complex, Camimil, Calapan City, Oriental Mindoro.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.
