WHEREAS, there is an infrastructure project funded through the LGSF-DRRP FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Repair of 3 CL in San Antonio ES, Puerto Galera, Oriental Mindoro and Repair of 1 CL in Sto. Nino ES, Puerto Galera, Oriental Mindoro and Repair of 1 CL in Sto. Nino ES, Puerto Galera, Oriental Mindoro (Repair of 6 Classroom, Grade III-Patient (8m x 7m), Grade I-Obedient (7m x 7m), & Arroyo Building (8m x 7m). Ceiling and Roofing./Repair of 1 Classroom (9m x 5m) Roofing, Ceiling, & Electrical);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-017-A) in PhilGEPS Website on January 22, 2022 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Repair of 3 CL in San Antonio ES, Puerto Galera, Oriental Mindoro and Repair of 1 CL in Sto. Niño ES, Puerto Galera, Oriental Mindoro (Repair of 3 Classroom, Grade III-Patient (8m x 7m), Grade I-Obedient (7m x 7m), & Arroyo Building (8m x 7m). Ceiling and Roofing./Repair of 1 Classroom (9m x 5m) Roofing, Ceiling, & Electrical):

WHEREAS, in response to the said advertisement, one (1) prospective bidder/contractor submitted application for eligibility and purchased bid documents;

1. RADEL CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on January 31, 2022, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on **January 31**, **2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **RADEL CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
