DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RADEL CONSTRUCTION with office address along C-5 Road. Sta. Isabel, Calapan City, Oriental Mindoro represented by ENGR. ADELFA P. PEREZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair of 3 CL in San Antonio ES, Puerto Galera, Oriental Mindoro and Repair of 1 CL in Sto. Niño ES, Puerto Galera, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount SEVEN HUNDRED NINETY EIGHT THOUSAND SIX HUNDRED ONE PESOS AND 23/100 ONLY (Php 798,601.23) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
