1. The Provincial Government of Oriental Mindoro (PGOM) through the LGSF – DRRP FY 2021 intends to apply the sum of **Seven Hundred Ninety Nine Thousand One Hundred Sixty Eight Pesos Only (Php 799,168.00)** being the approved Budget for the Contract (ABC) to payment under the contract for **“Repair of 3 CL in San Antonio ES, Puerto Galera, Or. Mindoro and Repair of 1 CL in Sto. Niño ES, Puerto Galera, Or. Mindoro”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for **“Repair of 3 CL in San Antonio ES, Puerto Galera, Or. Mindoro and Repair of 1 CL in Sto. Niño ES, Puerto Galera, Or. Mindoro”**. Completion of the Works is **39 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
