## CONTRACT AGREEMENT

FEB 1 8 2022 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SHANLEY CONSTRUCTION with office address at Carreon St. Centro East, Santiago City, Isabela represented by PATRICK A. TAGUINOD, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Multi- Purpose Building for LIKAS at Socorro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION THREE HUNDRED NINETY TWO THOUSAND NINE HUNDRED EIGHTY NINE PESOS AND 39/100 ONLY (Php 1,392,989.39) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
