Construction of Multi-Purpose Building for LIKAS at Socorro, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the LGSF DRRP FY 2021 intends to apply the sum of One Million Three Hundred Ninety Four Thousand Three Hundred One Pesos and 44/100 Only (Php 1,394,301.44) being the Approved Budget for the Contract (ABC) to payment under the contract for "Construction of Multi-Purpose Building for LIKAS at Socorro, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Multi-Purpose Building for LIKAS at Socorro, Oriental Mindoro". Completion of the Works is 67 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
