**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND  
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT  
(INFRASTRUCTURE)**

**Resolution No. 013, Series of 2022**

**WHEREAS**, there is an infrastructure project funded through the LGSF-DRRP FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Drying Facility at Victoria, Victoria, Oriental Mindoro (Construction of 8.0m x 14.0m Drying Facility. Embankment (H=1.00m))**;

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-020) in PhilGEPS Website on **January 10, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Drying Facility at Victoria, Victoria, Oriental Mindoro (Construction of 8.0m x 14.0m Drying Facility. Embankment (H=1.00m))**;

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. RJJJ ENGINEERING SERVICES**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **January 31, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **January 31, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **RJJJ ENGINEERING SERVICES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

**WHEREAS**, the detailed evaluation of bids conducted on **January 31, 2022** found out that bid price of **RJJJ ENGINEERING SERVICES** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

**NOW, THEREFORE**, We the Members of the Bids and Awards Committee, in our meeting on **February 09, 2022** hereby **RESOLVE**, as it is hereby **RESOLVED**:
