**BAC RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID (LCRB) A  
 (INFRASTRUCTURE)**

**Resolution No. 022, Series of 2022**

**WHEREAS**, there is an infrastructure project funded through the LGSF-DRRP FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair of 2 CL in Puting Cacao ES, Pola, Oriental Mindoro and Repair of 4 CL in Subaan ES, Socorro, Oriental Mindoro (Repair of 2 CL Kinder Room – Removal and replacement of roofing works, ceiling, electrical and replacement of doors and damages jalousy blades/Improvement of partition for 3 Classroom, Removal & Replacement of Doors & Windows for 4 CL & Removal & Replacement of Ceiling includes Outside Ceiling for 3 CL, (CL 1,2,3), Electrical Works & Window Grills for 3 CL);**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-022) in PhilGEPS Website on **January 10, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair of 2 CL in Puting Cacao ES, Pola, Oriental Mindoro and Repair of 4 CL in Subaan ES, Socorro, Oriental Mindoro (Repair of 2 CL Kinder Room – Removal and replacement of roofing works, ceiling, electrical and replacement of doors and damages jalousy blades/Improvement of partition for 3 Classroom, Removal & Replacement of Doors & Windows for 4 CL & Removal & Replacement of Ceiling includes Outside Ceiling for 3 CL, (CL 1,2,3), Electrical Works & Window Grills for 3 CL);**

**WHEREAS**, in response to the said advertisement, **two (2) prospective bidders/contractors** submitted application for eligibility and purchased bid documents;

1. **811 TRADING AND CONSTRUCTION**
2. **RJJJ ENGINEERING SERVICES**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **January 31, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **January 31, 2022** eligibility check was conducted to two (2) bidders/contractors mentioned above and were found eligible by the BAC;

**WHEREAS**, all bid proposals submitted during the opening of bid were examined and found substantially complied with the technical and financial proposals, thereby making all bid proposals passed the preliminary examination of bid as their corresponding bid price read out as follows.

**WHEREAS**, the detailed evaluation and comparison of bids conducted on **January 31, 2022** found out that bid price of **811 TRADING AND CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Lowest Calculated Bid**;

**WHEREAS**, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **811 TRADING AND CONSTRUCTION** with **Lowest Calculated Bid**, its bid passed the post qualification process conducted on **February 03, 2022**, thereby making its bid found to be responsive;
