CONTRACT AGREEMENT

THIS AGREEMENT, made this FEB 21 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and R. G. DIAZ BUILDERS & TRADING with office address at 10 San Nicolas, Betis, Guagua, Pampanga represented by RODERICK G. DIAZ, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Local Access Road Opening (Dangare and Viakalan), Villa Cerveza, Victoria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINETEEN MILLION FOUR HUNDRED EIGHTY SIX THOUSAND SEVEN HUNDRED EIGHTY TWO PESOS AND 76/100 ONLY (Php 19,486,782.76) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
