CONTRACT AGREEMENT

THIS AGREEMENT, made this FEB 18 2022 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **ADL CONSTRAK** with office address at Bagumbayan, Roxas, Oriental Mindoro represented by **ALEX D. LAQUI**, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Upgrading of Local Access Road, San Isidro, Bulalacao, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **SIXTEEN MILLION NINE HUNDRED NINETY ONE THOUSAND SIX HUNDRED SEVEN PESOS AND 23/100 ONLY (Php 16,991,607.23)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
