**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **LGSF-DRRP FY 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair of Barangay Hall at Libertad, Bongabong, Oriental Mindoro (Repair of Barangay hall (10mx7.0m) Repair of Ceiling, Roofing and Roof Framing, and Electrical. Including painting for concrete, steel and roof sheet);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-027-A) in PhilGEPS Website on **January 22, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair of Barangay Hall at Libertad, Bongabong, Oriental Mindoro (Repair of Barangay hall (10mx7.0m) Repair of Ceiling, Roofing and Roof Framing, and Electrical. Including painting for concrete, steel and roof sheet);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. RJJJ ENGINEERING SERVICES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **January 31, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **January 31, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **RJJJ ENGINEERING SERVICES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **January 31, 2022** found out that bid price of **RJJJ ENGINEERING SERVICES** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
