DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RJJJ ENGINEERING SERVICES with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. RECTO, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair of Barangay Hall at Libertad, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount SIX HUNDRED FORTY FIVE THOUSAND FIFTY PESOS AND 39/100 (Php 645,050.39) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
