INVITATION TO BID IB NO. CW 2022 – 027

Repair of Barangay Hall at Libertad, Bongabong, Oriental Mindoro

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **LGSF – DRRP FY 2021** intends to apply the sum of **Six Hundred Forty Eight Thousand Eight Hundred Sixty Two Pesos and 92/100 Only (Php 648,862.92)** being the approved Budget for the Contract (ABC) to payment under the contract for **“Repair of Barangay Hall at Libertad, Bongabong, Oriental Mindoro”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **“Repair of Barangay Hall at Libertad, Bongabong, Oriental Mindoro”**. Completion of the Works is **34 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
