RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT  
(INFRASTRUCTURE)**

**WHEREAS**, there is an infrastructure project funded through the LGSF-DRRP FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Improvement of Day Care Center at Leuteboro II, Socorro, Oriental Mindoro (Improvement of Day Care Center with removal of structures, reinforced concrete works, masonry works, roofing works, ceiling, electrical, painting, tile works and removal/replacement of doors & windows)**;

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-028-A) in PhilGEPS Website on **January 22, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Improvement of Day Care Center at Leuteboro II, Socorro, Oriental Mindoro (Improvement of Day Care Center with removal of structures, reinforced concrete works, masonry works, roofing works, ceiling, electrical, painting, tile works and removal/replacement of doors & windows)**;

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. SHANLEY CONSTRUCTION**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **January 31, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **January 31, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **SHANLEY CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
