CONTRACT AGREEMENT

THIS AGREEMENT, made this FEB 2 4 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and DK CONSTRUCTION with office address at Barcenaga, Naujan, Oriental Mindoro represented by REGINO C. EVANGELISTA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Senior Citizen's Federation Building at Sta. Isabel, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION THREE HUNDRED EIGHTY ONE THOUSAND NINE HUNDRED EIGHTY FOUR PESOS AND 22/100 ONLY (Php 1,381,984.22). by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - D. Performance Security
 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements
