**BAC RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID (LCRB) AND  
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT  
(INFRASTRUCTURE)**

**Resolution No. 029, Series of 2022**

**WHEREAS**, there is an infrastructure project funded through the LGSF-SBDP FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Local Access Roads from Benli Proper to Sitio Caguray, Bulalacao, Oriental Mindoro (Limits=0+000.00-0+430.00, Net Length=1430.00 meters, Road Width incl. Shouldering (m)=6.2, Road Width(m)=5);**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-031) in PhilGEPS Website on **January 31, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Concreting of Local Access Roads from Benli Proper to Sitio Caguray, Bulalacao, Oriental Mindoro (Limits=0+000.00-0+430.00, Net Length=1430.00 meters, Road Width incl. Shouldering (m)=6.2, Road Width(m)=5);**

**WHEREAS**, in response to the said advertisement, **two (2) prospective bidders/contractors** submitted application for eligibility and purchased bid documents;

- 1. GEMWEALTH CONSTRUCTION AND TRADING CORPORATION**
- 2. MDH CONSTRUCTION**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **February 21, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **February 21, 2022** eligibility check was conducted to two (2) bidders/contractors mentioned above and were found eligible by the BAC;

**WHEREAS**, all bid proposals submitted during the opening of bid were examined and found substantially complied with the technical and financial proposals, thereby making all bid proposals passed the preliminary examination of bid as their corresponding bid price read out as follows.
