MAR 1 1 2022 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter "ENTITY" and GEMWEALTH CONSTRUCTION AND CORPORATION with office address at Lapu-lapu, Ibaan, Batangas represented by CLYDE E. SOTTO, the Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Local Access Roads from Benli Proper to Sitio Caguray, Bulalacao, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOURTEEN MILLION NINE HUNDRED SEVENTY SIX THOUSAND TWO HUNDRED EIGHT PESOS AND 57/100 ONLY (Php 14,976,208.57) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
