DOLOR, MPA, Ph.D., Provincial Governor hereinafter the "ENTITY" and GEMWEALTH CONSTRUCTION AND CORPORATION with office address at Lapu-lapu, Ibaan, Batangas represented by CLYDE E. SOTTO, the Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Upgrading of Local Access Road from Sitio Proper to Sitio Bato, Nasucob, Bulalacao, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION NINE HUNDRED NINETY SIX THOUSAND FOUR HUNDRED NINETY FIVE PESOS AND 27/100 ONLY (Php 2,996,495.27) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
