Upgrading of Local Access Road from Sitio Proper to Sitio Bato, Nasucob, Bulalacao, Or. Mindoro

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **LGSF – SBDP FY 2021** intends to apply the sum of **Two Million Nine Hundred Ninety Nine Thousand One Hundred Fifty Five Pesos and 17/100 Only (Php 2,999,155.17)** being the Approved Budget for the Contract (ABC) to payment under the contract for **“Upgrading of Local Access Road from Sitio Proper to Sitio Bato, Nasucob, Bulalacao, Or. Mindoro”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for **“Upgrading of Local Access Road from Sitio Proper to Sitio Bato, Nasucob, Bulalacao, Or. Mindoro”**. Completion of the Works is **52 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
