**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the LGSF-SBDP FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Local Access Road Upgrading in Brgy. Buong Lupa, Gloria, Oriental Mindoro (Limits: 0+000.00 to 0+950.00, Net Length: 950.00 meters, Road Width incl. Concrete shouldering: 8, Road Width (m): 5)**;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-035) in PhilGEPS Website on **February 07, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Local Access Road Upgrading in Brgy. Buong Lupa, Gloria, Oriental Mindoro (Limits: 0+000.00 to 0+950.00, Net Length: 950.00 meters, Road Width incl. Concrete shouldering: 8, Road Width (m): 5)**;

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. 876 CONSTRUCTION AND SUPPLY

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **February 28, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **February 28, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **876 CONSTRUCTION AND SUPPLY** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **February 28, 2022** found out that bid price of **876 CONSTRUCTION AND SUPPLY** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
