RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **20% DF-CA FY 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Drainage Canal at So. Bario Hall, Poblacion, Bansud, Oriental Mindoro (Construction of Canals: Source of Aggregate Orconuma River; Canal Station Limit Station 1 0+000.00-0+192.00 Leftside (Construction) Station 2 0+000.00-0+056.00 (for rehab. of cover) Canal Length=248.00m);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-040) in PhilGEPS Website on **February 12, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Drainage Canal at So. Bario Hall, Poblacion, Bansud, Oriental Mindoro (Construction of Canals: Source of Aggregate Orconuma River; Canal Station Limit Station 1 0+000.00-0+192.00 Leftside (Construction) Station 2 0+000.00-0+056.00 (for rehab. of cover) Canal Length=248.00m);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. 811 TRADING AND CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **February 21, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **February 21, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **811 TRADING AND CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
