**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND  
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT  
(INFRASTRUCTURE)**

**Resolution No. 035, Series of 2022**

**WHEREAS**, there is an infrastructure project funded through the **20% DF-CA FY 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Water System at Benli, Bulalacao, Oriental Mindoro (Construction of Water System; Construction of Spring Box (2x2x1.5m), Underground Water Tank (3x3x2m), Water Tank (3x2x2.18m), 1 Pumphouse (2x2m), Installation of Water Pump and 2" HDPE Pipes (26 rolls);**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-041) in PhilGEPS Website on **February 12, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Water System at Benli, Bulalacao, Oriental Mindoro (Construction of Water System; Construction of Spring Box (2x2x1.5m), Underground Water Tank (3x3x2m), Water Tank (3x2x2.18m), 1 Pumphouse (2x2m), Installation of Water Pump and 2" HDPE Pipes (26 rolls);**

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. SOSEP BUILDERS**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **February 21, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **February 21, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **SOSEP BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

**WHEREAS**, the detailed evaluation of bids conducted on **February 21, 2022** found out that bid price of **SOSEP BUILDERS** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
