## CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 1 8 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and KASANGA CONSTRUCTION AND SUPPLIES with office address at Bayanan I, Calapan City, Oriental Mindoro represented by ROMEL B. DEINLA, General Manager, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Rehabilitation of Road and Construction of Drainage Canal at Ilang-Ilang St., Barangay. Tawiran, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY THREE THOUSAND NINE HUNDRED TWENTY PESOS AND 87/100 ONLY (Php 983,920.87) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
