**Rehabilitation of Road and Construction of Drainage Canal at Ilang-Ilang St.,
Barangay Tawiran, Calapan City, Oriental Mindoro**

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **20% DF - CA FY 2021** intends to apply the sum of **Nine Hundred Eighty Eight Thousand Four Hundred Eighteen Pesos and 05/100 Only (Php 988,418.05)** being the approved Budget for the Contract (ABC) to payment under the contract for "**Rehabilitation of Road and Construction of Drainage Canal at Ilang-Ilang St., Barangay Tawiran, Calapan City, Oriental Mindoro**". Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for "**Rehabilitation of Road and Construction of Drainage Canal at Ilang-Ilang St., Barangay Tawiran, Calapan City, Oriental Mindoro**". Completion of the Works is **21 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
