# Rehabilitation of Road and Construction of Drainage Canal at Ilang-Ilang St., Barangay Tawiran, Calapan City, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% DF CA FY 2021 intends to apply the sum of Nine Hundred Eighty Eight Thousand Four Hundred Eighteen Pesos and 05/100 Only (Php 988,418.05) being the approved Budget for the Contract (ABC) to payment under the contract for "Rehabilitation of Road and Construction of Drainage Canal at Ilang-Ilang St., Barangay Tawiran, Calapan City, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Rehabilitation of Road and Construction of Drainage Canal at Ilang-Ilang St., Barangay Tawiran, Calapan City, Oriental Mindoro". Completion of the Works is 21 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
